

# Wickham

COMMUNITY LAND TRUST





### History

- The Trust was established in June 2008 as a Company Limited by Guarantee and became a registered charity in 2010 (Charity No: 1134897)
- The Trust was approved as a registered provider of social housing in 2012 and took ownership of its first eight properties, in Houghton Gardens, in the same year.
- In 2022 the Trust acquired a further 10 homes in Wickham at Wykeham Vale.

### Purpose

 To provide affordable homes for those who cannot afford either to rent or to buy on the open market in or near the parish of Wickham and Knowle where they or their families grew up or they are employed.

#### The Trust Board

 The charity is led by a Board of Trustees, the majority of whom live in Wickham and who all give their time and expertise voluntarily to the Trust.

#### Affordable housing

- Wickham Community Land Trust (WCLT) rental properties are available at discounts from open market rents. Rents vary depending on the conditions dictated by local authorities and legislation.
- Shared ownership properties are offered at 50% equity, with rent payable on the equity retained by the Trust.

### Permanently affordable

- WCLT rental properties are exempt from "the right to buy" provisions that apply to properties owned by Housing Associations.
- Applicants accepted into a shared ownership arrangement with the Trust can 'staircase' to no more than 80% of the value of the property.
- WCLT has the right to re-acquire
  the property when a shared owner
  wishes to sell. WCLT affordable homes
  thus remain permanently in the
  ownership of the Trust for the benefit
  of future generations of local people.

#### The Allocation of Homes

WCLT controls the application and allocation processes for occupation of the homes it provides. These processes have been accepted by Winchester City Council and the Charity Commission as appropriate for meeting the Trust's charitable aims.

### Funding

To acquire its homes, WCLT has received at various times, grants from Homes England, Winchester City Council, South Downs National Park and Hyde Housing, plus commercial loans from ethical banks and a significant legacy donation from the family of Dick and Joyce Warwick.



### Benefits brought to the community

- Secure accommodation for those with strong local connections who are unable to buy or rent on the open market.
- Good quality housing for those living in situations inadequate or unsuitable for their needs.
- Increased family and community cohesion by virtue of the "local connection" qualification required to secure a WCLT home.
- Provision of affordable homes for local key workers, vital to the sustainability of the community.
- Environmental gain when residents live close to their work.
- Assets, now worth over £3.5million, remain in local management and control for the perpetual benefit of residents in Wickham and Knowle Parish.

### Supporting WCLT through gifts in your wil

WCLT is dependent on grants and donations from supporters to make it financially possible to continue our work and to increase the opportunities for local families to benefit from our affordable homes.

One way you might consider supporting us is through a legacy in your will. Should you decide to adopt this suggestion, your gift will be used for the sole purpose of purchasing and maintaining affordable housing in Wickham Parish for local people who would otherwise have to leave the area to seek cheaper housing elsewhere.

Pledge to help us provide affordable housing to local people with a gift in your will:

### Why do I need a will?

A will is one of the most important documents you will ever write. It is the only way to make sure the people and the causes you care about are looked after; it is where you can decide what happens to your money and possessions.

### What happens if I do not have a will?

If you do not have a will or if your will is not valid (e.g. your will is not correctly signed or witnessed), your estate is said to be 'intestate'. This means your wishes may not be carried out. Having a professionally written up to date will is the best way to make sure your wishes are met.

## Why do people leave a gift in their will to Wickham Community Land Trust?

In older age, many people have been fortunate to have significant assets within their house and property.

However, for the younger generation it is becoming increasingly difficult to afford a home. The private rental sector is also an expensive option for many people, particularly for those living alone or on low incomes, and provides limited security of tenure.

By deciding to leave a gift in your will to WCLT you will enable homes to be purchased, maintained and held in perpetuity for people and their families who have local connections to Wickham and Knowle. Leaving a gift in your will to a charity, such as WCLT, can also help to reduce your Inheritance Tax bill.

### Dick and Joyce Warwick's legacy

In memory of Dick and Joyce Warwick, their family gave a significant donation from their legacy to WCLT. Dick was a local business owner and Joyce a social worker who were involved with the community in Wickham throughout their lives.

As John, their son, explained:

`Ensuring affordable homes are available to those who live and work in Wickham was a shared wish. Their financial assistance has been a vital contribution towards the cost of purchasing new homes for local people in Wickham at affordable rents and will be a lasting tribute to them both.'
